## 1. INTRODUCTION

Local Governments and Climate Change (LGCC) has been implemented in Cambodia since 2011 with technical and financial assistance of “Local Climate Adaptive Living Facility” (LoCAL), aiming support local governments to develop plans and to finance investments in order to enhance the resilience of local communities to the impacts of climate change. LGCC project was designed and implemented within the framework of LoCAL project which is a UNCDF Global project to provide access for local governments in least developed countries to climate change adaptation (CCA) finance.

The LGCC project is implemented by the NCDD Secretariat (NCDDS), consisting of four key results in the areas of (1) sub-national climate change adaptation investments, (2) capacity development, (3) programme development, and (4) learning, innovation and knowledge management, aimed at a strengthened understanding of the climate adaptive benefits resulting from local government action and an expanded range of potential climate change adaptation interventions. The project is implemented in 5 districts of Battambang province and one municipality and 2 districts of Takeo province.

Phase 1 of LGCC was a pilot implemented in 2012 and Phase 2 (LGCC2) was implemented from 2013-2016 with funding support from SIDA. During 2016, SIDA also agreed to provide funding for a Bridging Phase of LGCC from 2017-2019 to continue supporting the LGCC2 and mobilise funds for scaling up the LGCC approach.

In 2019 the UNCDF and NCDDS signed an LoA, with a total budget of USD 260,082, to continue supporting NCDDS aimed at providing capacity development and mainstreaming CCA into district development plan and investment program, assisting the SNAs in completing and closing the investment projects and supporting NCDDS on accreditation process, which was started since 2015, to gain direct access to the Green Climate Fund (GCF).

As a result, in November 2019 NCDDS was recognized as a National Implementing Entity (NIE) of GCF. In May 2020, the LoA 2019 was amended, with an additional budget of USD 103,400, and extended to 2020-2021 to continue supporting NCDDS to go through the accreditation process as an NIE and providing technical assistance to prepare a proposal to GCF for roll out of the LoCAL.

This second quarterly progress report covers a period from 01 April-30 June 2020 describing key achievements and challenges as well as actions taken to address these challenges during the reporting period. The report is divided into seven sections as followings:

## 2. SUMMARY OF KEY ACHIEVEMENTS

This report covers a three-month period from April-June 2020. During this period, key achievements of the project are described and summarized as followings:

Importantly during this reporting period, closing contract reports of the 36 district and commune projects have been prepared and signed by the target districts and communes. End of Joint Decision (JD) reports between NCDDS and target provinces of TAK and BAT have been signed and closed.

End of LGCC BP project (2017-2019) assessment was conducted and commissioned by the UNCDF LoCAL Programme from January-March 2020. The final report finalized and concluded with comments and inputs from relevant stakeholders such as UNCDF, NCDDS.

Importantly on GCF accreditation process, key achievements during this period include

Accreditation Master Agreement (AMA) between the RGC and GCF and NCDD has been signed on 8 May 2020, Concept Note on LGCC3 has been drafted and internally shared within NCDDS for comment and input, Information Disclosure Policy, Grievance Redress Mechanism and Project Management Manual have been reviewed and revised. TOR for audit on the implementation plan and Roadmap finalized and negotiated with Price Waterhouse Coopers (PWC) on their financial proposal.

Studies to identify a new target commune to implement the pilot project on safe and resilient water supply system has been conducted. Report on the studies prepared and submitted to NCDDS management for review and advice.

#### 4. SUMMARY FINANCIAL REPORT

The total budget for 2020 Workplan, according to amendment no.1 made on May 2020, is USD 301,527.72 in which USD 150,000 or 50% of the total budget is allocated for investment on safe and resilience water pilot project in BAT.

The total project expenditure as of this quarter is USD 43,798.13. Most of this expenditure mainly covered the activities related to closing of LGCC BP and project management and operation including staff salaries and field visits conducted by NCDD and provincial teams.

It should be noticed the expenditure rate is relatively low at 14.53% because it is calculated in comparison to the investment budget which is planned to implement in Q4, 2020.

Detailed expenditures of the project by quarter and activity are described in the Q2 financial report.

#### 5. KEY CHALLENGES AND ACTIONS TO BE TAKEN

Despite the key achievements as described in section 2 and section 3, the project implementation during this second quarter has encountered the global problem of COVID-19 pandemic and the problem related to change of the target commune of Wat Tamim, Sangkhae district for implementing the pilot activity on safe and resilient water supply system because the water supply of this commune has been licensed by the Ministry of Industry, Technology and Innovation to a local private investor. These problems have seriously caused delaying and postponing the implementation of some project activities such as PMSD needs to conduct a feasibility study again to identify a new target commune to implement the water supply project, the concept note on LGCC3 project for GCF funding, Information Disclosure Policy, Grievance Redress Mechanism and Project Management Manual have not yet been reviewed and finalized due to delay in conducting consultations with relevant stakeholders,

In addressing the problem regarding the change of the target commune for implementing the water supply project, the PMSD team has conducted several field visits to BAT to study and identify the potential communes for implementing this water supply project. Report on the studies has been prepared and submitted to NCDD management for review and advice.

Additionally, to improve the project implementation in the coming quarters, PMSD will establish networks within NCDD and change its strategies in communicating and working with project stakeholders via online such as Skype, BlueJeans and other ways as effective and appropriate.



## 6. CONCLUSION

In summary all 6 activities and management of the project have been implemented and mainly achieved results as planned for instance the agreements between NCDDDS and the BAT and TAK have been closed, AMA between GRC and GCF signed on 8 May 2020, Information Disclosure Policy, Grievance Redress Mechanism and Project Management Manual have been reviewed and revised, Concept Note on LGCC3 drafted and shared internally within NCDDDS and UNCDF for comments and inputs; and TOR for external audit on the Implementation Plan and Roadmap has been finalised and negotiated with PWC on their financial proposal. The PMSD team has also conducted several field studies in BAT to identify a new target commune for implementing the project on safe and resilient water supply system. Report of the studies has been prepared and submitted to NCDDDS management for review and advice for further actions.
