1. Background

The National Committee for Sub-National Democratic Development (NCDD) is the first Direct Access Entity (DAE) accredited for Cambodia (in 2019), with an essential role to channel climate change grants to sub-national level (provinces, districts and communes). The capacity analysis done during the accreditation process has highlighted some remaining gaps and the accreditation is conditional on addressing these remaining gaps. In additions to the GCF readiness support approved for the NCDDS readiness activity in 2022, UNCDF along with other development partners such as the World Bank have committed its own resource to support NCDDS on filling other remaining gaps and conditions precedent to submission of proposal which are not covered by CF readiness budget for 2022 (the GCF readiness 2021 budget). UNCDF will support NCDD mainly on Reviewing and updating the safeguard check list and conduct ESS study for project proposal development.

In this context, NCDDS hire an individual consultant for a position Environmental and Social Safeguard Assessment Consultant (ESSAC).

2. Scope of works

The consultant will help NCDDS to:

- Produce Impact Assessment Report on the Implementation of Environmental and Social Safeguard of Sub-national Investment Project
- Produce Environmental and Social Safeguard check list for Sub-national Investment Project
- Develop a report format on Implementation of Environmental and Social Safeguard

3. Methodology

The features of the methodology should include the following:

- 1. Impact Assessment Report on the Implementation of Environmental and Social Safeguard of Sub-national Investment Project:
 - Desk review on the implementation of current Environmental and Social Safeguard in subnational investment project
 - Randomly data collection at SNAs
 - Report should reflect on gender and climate change response and complain handing on the impact of investment project on environmental and social safeguarding
 - Consultation and validation with relevant stakeholders (National Agencies, DPs, SNAs, NGOs...)

- Site visit and consultation with implementor at SNA and NCDDS' safeguard team

 - Suggested change from descriptive report to analytical report included gender and climate change
 - Provide capacity training to ESS team to use new report format
