1. The Kingdom of Cambodia has received a Loan/ Grant: *IDA Credit No. 6394 from the World Bank toward the cost of the Cambodia Nutrition Project (CNP) which National Committee for Sub-National Democratic Development Secretariat (NCDDS) is the IA of the Project, and it intends to apply part of the proceeds of this loan/ grant to payments under the Contract for Supply and Delivery of Office Equipment (IT Equipment) for CNP.*
2. The NCDDS now invites sealed bids from eligible and qualified bidders for *Delivery and Supply of Office Equipment (IT Equipment).*
3. Procurement will be conducted through National Competitive Bidding Procedures specified in the RGC's Standard Operating Procedures on Procurement for All Externally Financed Projects/Program, under the laws and regulations governing public procurement within the Kingdom of Cambodia, and in accordance with the Financing Agreement and Procurement Regulations of *World Bank.*
4. This invitation is open to all bidders.

6. Qualification requirements include:
 - *The bidder has satisfactorily completed at least two contracts for supply of similar goods in the preceding three years (2022, 2023, 2024) of not less than \$167,000.00 for each contract.*
 - *The bidder has completed contracts in the total cumulative in the preceding two years (2023, 2024) amount equal to at least \$667,000.00.*
 - *The Manufacturer of the offered goods, if a different entity from the Bidder, has experience of at least 3 years in the manufacturing of similar goods.*
 - *The bidder has availability of liquid assets through either: (i) access to a line of credit or cash in bank account of an amount at least \$167,000.00; or (ii) credit terms with vendors specifically for the goods to be supplied under the contract, and valid for at least 6 months after the deadline date for submission of bids specified in ITB Clause 21.*
7. A completed set of Bidding Documents in English may be purchased by interested bidders on the submission of a written application to the address given below and upon payment of a non-refundable fee \$35.00 or its equivalent in Cambodian Riel. The method of payment will be Cash. The Bidding Documents will be collected in person at the discretion of the bidder. Other than payment of the non-refundable fee specified above, there shall be no other conditions for purchase of the bidding documents.
